On 28 September 2021, the Specified Purchaser(s) shall personally (or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor) attend the place where the sale will take place as stated in the Information on Sales Arrangements for Car Parking Spaces of Phase IV of LOHAS Park (applicable to Specified Purchasers with an Option only) issued on 14 September 2021 ("ICC 21/F Venue") according to " Sales Date and Check-in Timeslot for Registrants " in the ballot result above. The Specified Purchaser(s) must bring along the the Preliminary Agreement for Sale and Purchase in respect of the Relevant Property , his/her/their original H.K.I.D. Card/Passport and, (for company applicant) copy of company documentations (including Business Registration Certificate, Certificate of Incorporation, Forms D1, D2, NNC1 or ND2B or latest annual return (as applicable), board resolutions for purchasing the specified car parking space(s) and company chop). The specified purchasers whose identities have been verified by the Vendor will proceed to select not more than two of the specified car parking spaces which is still available at the time of selection in the order of priority according to the "Ballot Result Sequence".
